## PARISH OF RADNAGE

## A MEETING OF THE PARISH COUNCIL WAS HELD ON Wednesday 8<sup>th</sup> February 2023 AT 8 PM AT RADNAGE VILLAGE HALL

**Present:** Councillors: Vice Chair, Cllr Dr Jez Lofts, Cllr Tony Eden, Cllr Mr Cris Everett, Cty Councillor Carl Etholen and Clerk Ms Lisa Stibbs.

There were 6 members of the public present.

1. The Chairman welcomed everyone to the meeting. Apologies had been received from Chairman, Councillor Ungless and County Councillors Robert Carrington and Shade Adoh.

## MEETING CLOSED FOR PUBLIC SESSION (Extended session)

## **Road Safety**

It was agreed by Vice Chair Cllr Lofts, Cllr Eden and Cllr Everett that the The Public Session would be extended in order to discuss in greater detail the suggestions regarding traffic safety on the roads around Radnage and particularly the school. Radnage Primary School had conducted a survey of the parents attending the school regarding road safety. The results had been sent out to the Councillors and the responses were discussed in this public session. There were many suggestions towards improving safety some of which are listed below:

School Travel Plan: Staggered start and finish times for different year groups.

Possibility of Sleeping Policeman

Lollipop Lady (possible funding from NWCCB)

Community Speed Watch

Traffic Survey. This could start in April 2023.

Sign at the school end of Green Lane warning of school. Could be more visible for traffic coming in from Stokenchurch end of City Road.

Ensure the hedge before the school is cut right back to improve visibility.

Removable bollards with school children on them. (There is a possibility of funding from NWCCB)

The Parish Council could look into a speed limit review (for 20mph) but this would still be reliant on cars adhering to the speed limit.

All of these options and more were discussed and a Sub Committee will be formed to go through the list, check through what is doable and what is likely to have the best impact.

## Kings Coronation Celebrations May 7th 2023

Also discussed in the public session were various ideas and plans for the Coronation Celebrations in May. Many ideas were put forward. A group of volunteers has been formed and will meet in the next two weeks (date TBC)

**Village Hall:** <u>Driveway</u>: Clerk has received one quote for the driveway works. John Lee has been out to look but has not yet sent in a quote. Clerk will bring the first quote to the next meeting in March for the Councillors to discuss.

<u>Fire Risk Assessment</u>. We are still waiting for the complete report back from Fire System Solutions which Cllr Eden and the Clerk will chase up.

## **Roof and Ceiling repairs**

It was discussed that as the roof work was now urgent, (There is water dripping down over the gutter and will need a roofer to fix ) Cllr Everett would contact his roofer and ask him to go ahead with the work even with the price increase.

There is water damage on the ceiling in the entrance hall after the burst pipes. This will need to be looked at in the loft area as well as the ceiling. Cllr Eden will try to obtain quotes from builders for the repairs.

**Recycling Bins**, There are now 3 keys to the blue recycling bins (as rubbish was being dumped in them that was not from the hirers) One of the keys is on the set in key box 1 for hall hirers and the other two keys are in the key cabinet in the hall)

**Playground,** Nothing to report this month.

**Play Area** The Councillors agreed to have a wooden bench, dedicated in memory to HRH Queen Elizabeth II in the play area. Jane from the WI has confirmed that they would like to donate towards the cost of this. Cllr Lofts will liaise with Jane.

**Gully in Green Lane** Glynn has now cleared the Gully outside the village hall in Green Lane. This was in response to a letter from GLRA requesting RPC, as the frontage holders of the Village Hall to maintain this part of Green Lane.

#### 11. Allotments & Pasture

Cllr Lofts will meet with Sam Brown, The Headmaster at Radnage Primary to discuss their plot at Green Lane Allotments and will ask for volunteers to help with rotavating the plots for the school and will borrow Cllr Everett's rotavator.

The gatepost at Chapel allotments has been repaired.

There is a large amount of brambles at Chapel Allotments. Cllrs Lofts will speak to Glynn and Connor to see if they can cut them down.

- **12. Defibrilators** Cllr Lofts still looking for an alternative location, possibly Bennett End area as it is the other end of the village. The Radnage Royal British legion have also approached the Parish Council regarding a donation towards a Defibriliator at their premises. This is pending waiting for further information i.e costs involved, from the Legion.
- 13 Noticeboards/Bus shelters A design for the combined shelves and noticeboards for the bus shelters will be circulated to the Councillors. After this has been agreed and installed, new noticeboards will be arranged for the other areas. Carried forward to March.

### 15. Clerks Matters - including late correspondence

The Clerk had received a complaint regarding off lead dogs running loose in Radnage Common Road. This was discussed at the meeting and the Clerk will draft a reply.

The Clerk had also received an email reporting motorbikes in Bottom Wood. This was discussed and Cllr Lofts will draft a reply.

Radnage Raiders are hoping to purchase new goal posts and have asked if they can keep them on the recreation ground. This has been deferred to the next meeting.
