- b. All agreed that representation at meetings of the SW Chilterns and Marlow Local Area Forum (SWC&M LAF) would be carried out when necessary. The Clerk was to circulate agendas and minutes to councillors.

5. Roles and Responsibilities

The various roles and responsibilities of the council were discussed at it was agreed that the following split of responsibilities would apply for the forthcoming year:

Village Hall Team: The village hall team would be led and co-ordinated by Cllr Jones, supported by Cllr Orchard. Meetings of the Village Hall team would take place outside of Parish Council meetings to discuss the general management and to co-ordinate proposals for council decisions. Cllr Fynn agreed to take on the minor maintenance and general ground works. Cllr Raven would take on the task of project management. Cllr Perring and Mr Coggrave would assist the team whenever possible.
